Security: The Community Room will be closed to the public during set up and hours when the vendor/exhibitor area is not open to the public. Items of value must be secured by the vendors when space is unattended. The Community Room will be locked at all other times. However, neither the City of Watsonville nor Monterey Bay Birding Festival will be liable for lost, stolen, or damaged items. All cash and any items of value should be either removed each night or secured by the vendor.

The Monterey Bay Birding Festival is an environmentally concerned organization. We reserve the right to disallow at any time during the festival, the sale of any product that is detrimental to the environment, harmful to wildlife, or made from animal products.
